EXECUTIVE ORDER NO. 08

Series of 2023

“AN ORDER TRANSFERRING THE DIRECT SUPERVISION ON THE OPERATION OF THE PUBLIC MARKET UNDER THE OFFICE OF THE MAYOR”

WHEREAS, Article X, Section 5 of the 1987 Constitution states that “Each local government unit shall have the power to create its own sources of revenues...”

WHEREAS, according to Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, local government units shall have the power and authority “to acquire, develop, lease, encumber, alienate, or otherwise dispose of real or personal property held by them in their proprietary capacity and to apply their resources and assets for productive, developmental, or welfare purposes, in the exercise or furtherance of their governmental or proprietary powers and functions and thereby ensure their development into self-reliant communities and active participants in the attainment of national goals”;

WHEREAS, Section 22 (d) of the same Code states that “Local government units shall enjoy full autonomy in the exercise of their proprietary functions and in the management of their economic enterprises”;

WHEREAS, the Public Market is one of main sources of revenue of the local government unit of Bayambang;

WHEREAS, the Public Market is currently operating under the Office of the Special Economic Enterprise (SEE) headed by Municipal Environment and Natural Resources Officer and OIC-SEE, Mr. Joseph Anthony S. Quinto;

WHEREAS, Special Order No. 18, series of 2022 designates Atty. Melinda Rose Fernandez as the OIC-Market Supervisor to continue in the provision of effective and efficient delivery of basic services to the people of Bayambang;

WHEREAS, there is a need to expedite the appropriate process in the approval and supervision of programs and projects at the Public Market;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, by virtue of the powers vested in me as the Local Chief Executive, do hereby declare:

THAT the operation of the Public Market shall be transferred under the direct supervision of the Office of the Municipal Mayor. Atty. Fernandez shall continue to fulfill her duties

and obligations as the OIC-Market Supervisor and shall directly report to the Municipal Mayor and/or the Special Assistant to the Office of the Mayor, Dr. Cezar T. Quiambao.

Furthermore, all other remaining functions under the SEE shall remain under the supervision of Mr. Quinto.

Separability Clause. If any provision of this Executive Order is declared or has been found invalid or unconstitutional, the other provisions not affected thereto shall remain valid and subsisting.

Repealing Clause. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended, or modified accordingly.

Effectivity. This Executive Order shall take effect immediately and shall remain in effect unless sooner revoked or amended.
