REORGANIZING THE LOCAL DRINKING WATER QUALITY MONITORING COMMITTEE OF BAYAMBANG, PANGASINAN

WHEREAS, Presidential Degree (PD) No, 856 of the code on sanitation states that the health of the people, being of paramount importance, all efforts of public service should be directed towards the protection and promotion of health and with the advance in the field of sanitation in recent years, there arises the need for updating and codifying our scattered sanitary laws to ensure that they are in keeping with modern standards of sanitation and provide a handy reference and guide for their enforcement;

WHEREAS, as provided in the implementing rules and regulations of Chapter II "Water Supply" of PD 856, the local health authority is mandated to establish a water surveillance program through the creation of Local Drinking Water Quality Monitoring Committee to oversee the operation of the water systems and the quality of water produced and distributed by them;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Mayor of the Municipality of Bayambang, by virtue of the powers vested in me by law do hereby order:

SECTION 1. RECOMPOSITION. The Local Drinking Water Monitoring Committee shall be reorganized with the following composition:

SECTION 2: FUNCTIONS, ROLES AND RESPONSIBILITIES

- a. Endorses annual work and financial plan on water quality surveillance to the municipal council for approval;
- b. Formulates policies, concerning implementation of water quality surveillance program addressing water quality issues;
- c. Initiates immediate sanitary survey for contaminated water supply sources;
- d. Initiates the regular collection and analyses of water samples on approved water sampling point;
- e. Analyses quarterly Water Quality Surveillance reports to determine trends in the quality of the drinking water supply for appropriate actions such as but not limited to water quality audit;
- f. Conducts regular quarterly meeting or as need arises; and
- g. Develop rules in the operation of the Committee including rules in decision-making and chairmanship.

SECTION 3. EFFECTIVITY, The Executive Order shall remain in force and effect upon signing unless sooner recalled, revoked or amended.

Let the copies of the Executive Order be furnished to the persons and departments concerned.
