EXECUTIVE ORDER NO. 46

“AN ORDER REORGANIZING/RECONSTITUTING THE MUNICIPAL PHYSICAL FITNESS AND SPORTS DEVELOPMENT COUNCIL OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN”

WHEREAS, Executive Order No. 63, as further strengthened by DILG Memorandum Circular No. 2003-23 dated 28 February 2003, provides for the creation/reactivation/reorganization of the Local Physical Fitness and Sports Development Councils;

WHEREAS, the Physical Fitness and Sports Development Council shall act as nationwide organizational network to assist the Philippine Sports Commission in the planning, information dissemination, actual implementation, and monitoring of the National Policy Programs of “Sports for all”;

WHEREAS, to carry out this mandate in coordination with the various government departments, agencies and private entities amidst this pandemic, there is a need for reorganizing/reconstituting the Municipal Physical Fitness and Sports Development Council of the Municipality of Bayambang, Pangasinan;

WHEREAS, Sports is a major contributor to economic and social development. Its contributor includes empowerment of women and of young people, individuals and communities, as well as to health, education and social inclusion objectives;

WHEREAS, ever since the pandemic struck in 2020, the Local Government Unit of Bayambang has been closely with all arms of our government to add momentum to the fight against pandemic;

WHEREAS, social and physical distancing measures, lockdown of business, schools and overall social life, which have become common place to curtail the spread of the disease have also disrupted many regular aspects of life including sports and physical activity;

WHEREAS, in observance with the health protocols to be observed during this pandemic, events/programs during the sports fest should be on live telecast or live feedback on social media whichever is available and feasible to avoid accruance of crowd;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby revise the membership of the MPFSDC of the Municipality of Bayambang, with the following:

SECTION 2. FUNCTIONS AND RESPONSIBILITIES. The MPFSDC shall perform the following:

- a. Meet at least once a month plan, and formulate a blueprint for the short, medium and long term for the sectoral sports based on the National Policy Programs of “SPORTS FOR ALL”, including a well-synchronized year-round calendar of sports activities and competitors culminating in a national “Palarong Pambansa”;
- b. Conduct local “Sports Summits” in consultation with other public and private entities concerned to identify and prioritize sports programs and activities in the Municipality and to monitor, review, and validate the program;
- c. Oversee and ensure the Implementation of the physical fitness, sports program and activities in the Municipality, i.e., DepEd, CHED, and TESDA for physical education and school sports; DOLE for Labor Sports; POC and NSAs for elite sports activities for international competition, and BAG for professional sports;
- d. Disseminate proper information on the national policy and program, including their local programs to encourage the active participation of their constituents on physical fitness and sports activities;
- e. Assist in the identification, recruitment and training of gifted and talented athletes who will represent the country in international sports competitions;
- f. Submit a quarterly report to the Chairman of the National PFSCD and furnish a copy of the same to the Philippine Sports Commission; and perform other functions deemed necessary to promote and implement the National Policy and Program.
- g. The Public Order and Safety Office will be the one who is in-charge in ensuring health status of the participants in accordance with protocols before participating in the events.

SECTION 3. EFFECTIVITY. This Executive Order shall take effect immediately and will continue until amended or revoked.

SECTION 6. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 8. EFFECTIVITY CLAUSE. This executive order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to offices and departments concerned, the Municipal Local Government Operations Officer, the Philippine National Police and all Barangays for their information and guidance.
