ESTABLISHING BUSINESS ONE-STOP-SHOP (BOSS) OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, in line with the Anti-Red Tape Program for Local Government, LGU's are mandated by the DILG to establish one-stop-shops to complement the simplification of their regulatory systems.

WHEREAS, Business One-Stop-Shop (BOSS) refers to an arrangement where a single common site or location is designated for all concerned agencies in the Business Permit Licensing System to receive and process application for business registration through a streamlined system;

WHEREAS, the establishment of a BOSS shortens the time spent in processing business licenses and permits either for renewal or for new investments;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the power vested in me by law, do hereby establish the Business One-Stop-Shop (BOSS) of the Municipality of Bayambang, Pangasinan, as follows:

SECTION 1. PERMANENT AREA FOR BOSS

Portion of the ground floor of the Municipal Annex Building is established as permanent office of business one-stop-shop of the Municipality of Bayambang all year-round, and the Balon Bayambang Event Center serves as the municipal one-stop-shop every January 2 to March 20 each year that can be extended until the end of the month of March.
