### EXECUTIVE ORDER NO. 72

#### **“REORGANIZING OF THE LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC) AND DEFINING ITS FUNCTIONS”**

**WHEREAS**, Republic Act No. 9208, otherwise known as the Anti-Trafficking in Persons Act of 2003, and the Republic Act No. 9262 or the Anti-Violence Against Women and their Children Act of 2004, are the two (2) national laws which provide stronger mandates and direction towards addressing human trafficking and violence against women and their children.

**WHEREAS**, Joint Memorandum Circular 2010-01 of the Department of the Interior and Local Government (DILG), the Department of Social Welfare and Development (DWSO) and the Department of Justice (DOJ) dated October 18, 2010 provides the creation of the Local Committee on Anti-Trafficking and Violence Against Women and their Children in Provincial, City and Municipal Level;

**NOW, THEREFORE I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO**, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the **Reorganization of the Local Committee On Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC)** in the Municipality of Bayambang, Pangasinan:

**SECTION 1. COMPOSITION.** The LCAT-VAWC shall be reorganized with the following composition:

**SECTION 2. FUNCTIONS.**

1. Institute policies and programs to protect women and children who are victims of trafficking and violence in order to formulate local ordinance and resolutions.
2. Create and establish systems on surveillance, investigation and rescue to ensure effective and efficient coordination.
3. Undertake information, education and advocacy campaign against trafficking in persons and Violence Against Women and Children (VAWC).
4. Monitor and oversee the strict implementation of RA 9262 and other related laws for the protection of women and children and of the Inter Agency Council Against Trafficking (IACAT) and Inter Agency Council Violence Against Women and Children (IACVAWAC) national plan of action.
5. Implement the programs and activities as stated in the national plan of action.
6. Implementation of programs for the rehabilitation of victims.

**SECTION 3. SECRETARIAT.** The Municipal Social Welfare and Development Office shall serve as the secretariat of this committee.

**SECTION 4. FUNDING.** Funds for monitoring the LCAT-VAWC functionality shall be charged against LGU budget, subject to usual accounting and auditing rules and regulations.

**SECTION V. EFFECTIVITY.** The executive order shall take effect immediately and will continue until amended or revoked.
