**“AN ORDER REORGANIZING THE MUNICIPAL HEALTH BOARD OF
BAYAMBANG, PANGASINAN”**

WHEREAS, pursuant to Section 102 of Local Government Code of 1991, there shall be established in every Municipality a Local Health Board;

WHEREAS, with the new sets of official, the Municipal Health Record of Bayambang is hereby reorganize;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

SECTION I. RECOMPOSITION. The Municipal Health Board reorganized with the following composition:

SECTION II. FUNCTIONS. The Municipal Health Board has the following functions:

- a. Proposed to the Sanggunian concerned in accordance with the standards criteria set by DOH, annual budgetary allocations for the operation and maintenance of health facilities and services within the municipality.
- b. Serve as an advisory committee to the Sanggunian concerned on the health agencies on matters such as, but not limited to, necessity for, and application of local appropriations for public health purposes; and
- c. Create committee which shall advice local health agencies on matters such as, but not limited to, technical and administrative standards of DOH; personnel selection discipline, budget review, operations review and similar functions.

SECTION III. MEETING AND QUORUM.

- a. The Municipal Health Board shall meet at least once a month or as often as may be necessary;
- b. A majority of the members of the board shall constitute a quorum, but the chairperson or the vice chairperson must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of all the majority of the members shall be necessary to approved such proposals.

SECTION IV. COMPENSATION AND REMUNERATION.

The Chairperson, Vice-Chairperson and members of the provincial, city or municipal health board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary traveling expenses and allowances chargeable against the funds of the local health board concerned, subject to existing accounting and auditing rules and regulations.

SECTION V. EFFECTIVITY. This Executive Order shall take effect immediately.
