## EXECUTIVE ORDER NO. 78 Series of 2023

## ABOLISHING THE INFORMATION SYSTEMS COMMITTEE AND TRANSFERRING ITS FUNCTIONS TO THE INFORMATION AND COMMUNICATIONS TECHNOLOGY OFFICE

WHEREAS, Public Office is a Public Trust. It is a settled principle of law that municipal corporations are agencies of the State for the promotion and maintenance of local self-government and as such are endowed with the police powers in order to effectively accomplish and carry out the declared objects of its creation;

WHEREAS, a Local Government Unit is a political subdivision of the State which is constituted by law and possessed of substantial control over its own affairs to develop not only at its own pace and discretion but also with its own resources and assets. With its broadened powers and increased responsibilities, a local government unit must now operate on a much larger scale including more extensive operations which entail more expenses;

WHEREAS, Title Three, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code, provides that every local government unit shall design and implement its own organizational structure taking into consideration its service requirements and financial capability;

WHEREAS, Executive Order No. 4, series of 2022, entitled "Information Technology Policy of the Municipal Government of Bayambang," established the Information Systems Committee with its functions;

WHEREAS, there is a need to streamline decision-making in the evaluation of prioritization of information systems to be developed and/or procured;

WHEREAS, the function can be competently carried out by the Information and Communications Technology Office (ICTO);

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby mandate the ABOLITION OF THE INFORMATION SYSTEMS COMMITTEE AND TRANSFERRING ITS FUNCTIONS TO THE INFORMATION AND COMMUNICATIONS TECHNOLOGY OFFICE:

SECTION I. SCOPE. This policy shall be applicable to the Local Government Unit of Bayambang (LGU-Bayambang).

**SECTION II. SEPARABILITY CLAUSE.** If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION III. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

**SECTION IV. EFFECTIVITY CLAUSE.** This Executive Order shall take effect immediately and will continue until amended or revoked.
