“AN ORDER RECOMPOSING THE GRIEVANCE AND REDRESS MECHANISM COMMITTEE FOR THE IMPLEMENTATION OF THE PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP) IN THE MUNICIPALITY OF BAYAMBANG”

WHEREAS, the Government of the Philippines has obtained a loan from the International Bank for Reconstruction and Development -World Bank (IBRD-WB) for the purpose of financing the Philippine Rural Development Project (PDRP) of the Department of Agriculture to support the government’s Millennium Development Goal for sustainable development;

WHEREAS, the Philippine Rural Development Project is a poverty reduction program of the Department of Agriculture which aims to improve the income and food security of rural poor and indigenous communities in the country;

WHEREAS, the Municipality of Bayambang is a participant in the said project that will mobilize LGUs in partnership with national government agencies in implementing the needed rural infrastructure and development projects targeting poor and marginalizes farming and fishing communities;

WHEREAS, there is a need to recompose the Grievance Redress Mechanism Committee which was created through Executive Order No. 66 series 2022 entitled: “Creating the Grievance and Redress Mechanism Framework for the Implementation of the Philippine Rural Development Project (PRDP) in the Municipality of Bayambang”, issued on November 07, 2022, which serves as project management element intended to seek feedback from beneficiaries and facilitate resolution concerns that may arise on project activities and performance;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of power vested in me by Law, do hereby recompose the Grievance and Redress Mechanism Committee of the Municipality of Bayambang for the implementation of the Philippine Rural Development Project, to wit:
