EXECUTIVE ORDER NO. 82

AN ORDER DECLARING SUSPENSION OF WORK IN THE LOCAL GOVERNMENT UNIT OF BAYAMBANG DUE TO TYPHOON "EGAY"

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as "Local Government Code of 1991" provides that "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective jurisdictions, local government units shall ensure and support, among other things, x x x promote health and safety x x x, maintain peace and order, and preserve the comfort and convenience of their inhabitants.";

WHEREAS, Executive Order No. 66, series of 2012 which prescribes the rules on the cancellation or suspension of classes and work in government offices due to typhoons, flooding, other weather disturbances and calamities also delegated the authority to cancel classes and work to local chief executives of the affected areas of typhoons and other calamities;

WHEREAS, the Philippine Atmospheric Geophysical and Astronomical Services Administration (PAGASA) said that Typhoon "Egay" nears super typhoon category and is expected to hit the provinces of Cagayan and Babuyan Island. Typhoon "Egay" is located east of Tuguegarao City, Cagayan and has already affected 26 provinces of Luzon. Due to Typhoon "Egay", the province of Pangasinan is already placed under Tropical Cyclone Wind Signal (TCWS) No. 1. Typhoon "Egay" is forecasted to strengthen the monsoon, though minimal to minor threat is expected, all possible risks to affected areas must be anticipated;

WHEREAS, to protect Bayambanguenos, and to ensure the safety of our townspeople and allow them to make arrangements to deal with the weather disturbance, there is a need to declare a suspension of work in the Local Government Unit of Bayambang, Pangasinan on **July 26, 2023 (Wednesday)**;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor, Bayambang, Pangasinan, and chair of the Municipal Disaster Risk Reduction and Management Council, by virtue of the powers vested in me by law, do hereby order:

"Baley ko, Pawilen ko, Aroen ko, tan Talungan ko"
