AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE ECOLOGICAL SOLID WASTE MANAGEMENT OFFICE

WHEREAS, the amount left under account OFFICE OF THE ECOLOGICAL SOLID WASTE MANAGEMENT -OTHER SUPPLIES AND MATERIALS, REPAIR AND MAINTENANCE-MACHINERIES AND REPAIR AND MAINTENANCE OF VEHICLES are not sufficient to meet the obligations under the said account;
