AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE OFFICE OF MUNICIPAL MAYOR

WHEREAS the amount left under account **OFFICE OF THE MUNICIPAL MAYOR- TRAVELLING EXPENSES AND REPAIR AND MAINTENANCE-BUILDINGS AND OTHER STRUCTURES** is not sufficient to meet the obligations under the said account;

WHEREAS the total amount of **TWO HUNDRED THOUSAND PESOS ONLY (P200,000.00)** is available to augment the balance under accounts **OFFICE OF THE MUNICIPAL MAYOR -REPAIR AND MAINTENANCE-FURNITURES AND FIXTURES AND REPAIR AND MAINTENANCE-MACHINERY AND EQUIPMENT** to be used for the travelling expenses of employees and repair of buildings and other structures of this Municipality;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby authorize Municipal Budget Officer Peter B. Caragan to transfer the **TWO HUNDRED THOUSAND PESOS ONLY (P 200,000.00)**;
