EXECUTIVE ORDER NO. 133
Series of 2023

“AN ORDER AUTHORIZING THE DESIGNATED MUNICIPAL LEGAL OFFICER, ATTY. BAYANI B. BRILLANTE JR. (ATTORNEY IV) TO ACT UPON THE APPLICATIONS FOR PERMITS TO HOLD PUBLIC MEETINGS, RALLIES, OR OTHER POLITICAL ACTIVITIES IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN”

WHEREAS, on June 7, 2023, the Commission on Elections (COMELEC) promulgated Resolution No. 10924 entitled General Guidelines and Other Related Laws for the October 30, 2023 Barangay and Sangguniang Kabataan Elections (BSKE) and All Succeeding BSKEs Thereafter;

WHEREAS, Republic Act No. 9006, otherwise known as the “Fair Elections Act” provides for the holding of free, orderly, honest, peaceful and credible elections through fair election practices;

WHEREAS, Section 257 of Comelec Resolution 10924, states that all applications for permits to hold public meetings, rallies and other similar political activities shall be filed with the authorized city or municipal official who shall acknowledge thereof in writing. Immediately after its filing, the application shall be posted in conspicuous place in the city hall or municipal building;

WHEREAS, Section 258, Action on Application for Permit, of Comelec Resolution 10924, states that within three (3) days after the filing of an application for permit to hold public meetings, rallies or other political activities, the local authority concern shall in writing on said application. Any application not acted upon within three (3) days from the date of its filing shall be deemed approved.

NOW, THEREFORE, I, HON. MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby authorize the Municipal Legal Officer, Atty. Bayani B. Brillante Jr. (Attorney IV) to act upon the applications for permits to hold public meetings, rallies, or other political activities for the Barangay and Sangguniang Kabataan Elections (BSKE) in the Municipality of Bayambang, Pangasinan.

This Executive Order shall take effect immediately.
