EXECUTIVE ORDER NO. 135

AN ORDER ESTABLISHING THE TECHNICAL WORKING GROUP (TWG) FOR THE FORMULATION OF WORKFORCE DEVELOPMENT PLAN (WDP) ON THE IMPLEMENTATION OF STRENGTHENING INITIATIVES FOR BALANCED GROWTH AND OPPORTUNITIES AT THE LOCALITIES (SIBOL)

WHEREAS, Article XII, Section 1 of the Constitution provides that "The goals of the national economy are a more equitable distribution of opportunities, income, and wealth; a sustained increase in the amount of goods and services produced by the nation for the benefit of the people; and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged";

WHEREAS, Article II, Section 9 of the Constitution declares that "The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all";

WHEREAS, Republic Act, 11494, also known as Bayanihan to Recover as One Act was enacted on September 11, 2020, providing for COVID-19 response and recovery interventions to the Philippine economy and society;

WHEREAS, Section 3 of Republic Act 11494 declares that the state shall be an effective allocation among the different local government units of their respective powers, functions, responsibilities, and resources;

WHEREAS, Section 2(m) of Republic Act 7160 pursuant that the national government shall ensure that decentralization contributes to the continuing improvement of the performance of local government units and the quality of community life;

WHEREAS, the Joint Memorandum Circular entitled, "Guidelines on the Implementation of Strengthening Initiatives for Balanced Growth and Opportunities at the Localities (SIBOL) aims to institutionalize a Workforce Development Program in LGU to generate employment and livelihood opportunities in their respective communities;

WHEREAS, there is a need to establish the Workforce Development Program – Technical Working Group for the Formulation and Implementation of the Workforce Development Plan;

NOW, THEREFORE, I MARY CLARE JUDITH PHYLLIS JOSE–QUIAMBAO, Municipal Mayor of Bayambang, Pangasinan, by the powers vested in me by law, do hereby order and direct the following:

SECTION 2. ROLES AND RESPONSIBILITIES. The Technical Working Group (TWG) is tasked to perform the following functions:

- a. Lead the formulation of the Workforce Development Plan;
- b. Endorse the list of qualified SIBOL beneficiaries;
- c. Recommend capacity development activities to enhance the competencies of concerned offices involved in the implementation of the program;
- d. Monitor the Implementation of the program; and
- e. Such functions that the LCE may deem proper for the implementation of the program.

SECTION 3. MEETINGS OF THE WDP - TWG. The TWG shall hold meetings once every six (6) months or as often as may be necessary. Special meetings may be called by the Chairperson or by a majority of each member.

SECTION 4. SECRETARIAT. The Secretariat of WDP-TWG shall be headed by the Public Employment and Service Office (PESO) of LGU Bayambang and PESO staff as a member, who is responsible for providing technical and administrative support, documenting proceedings, preparing reports, and providing other assistance as may be required by the group.

SECTION 5. REPEALING CLAUSE. All orders, rules and regulations, issuances, or any part coming from this office that is inconsistent with this order are hereby repealed, amended, or modified accordingly.

SECTION 6. EFFECTIVITY. This Executive Order shall take effect immediately.
