EXECUTIVE ORDER NO. 143

AN ORDER DESIGNATING THE OLD BAYAMBANG CENTRAL SCHOOL GROUNDS/AREA AS TEMPORARY PARKING SPACE FOR VEHICLES OF LGU EMPLOYEES AND THE GENERAL PUBLIC OF BAYAMBANG, PANGASINAN

WHEREAS, Section 16 of RA 7160, otherwise known as the Local Government Code of 1991 provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Section 16 of RA 7160 further provides that local government units shall, among other things, promote health and safety and preserve the comfort and convenience of their inhabitants;

WHEREAS, the municipality of Bayambang has experienced a significant increase in the number of vehicles due to the municipality's thriving economic activity and the attraction of visitors to the recently opened "Paskuhan Sa Bayambang 2023" organized by the Local Government Unit;

WHEREAS, the growing economic activities have created a demand for public parking spaces within the municipality, and there is a need to ensure that traffic in the town area is not disrupted by improperly parked vehicles;

WHEREAS, as the Local Chief Executive, I have the authority to identify, designate, and allow the temporary use of Local Government properties for the safety, order, and well-being of our constituents;

WHEREAS, the old Bayambang Central School lot, which is a property of the Local Government, determined by court decision in the Regional Trial Court branch 56 Civil Case No. SCC-4146, wherein the court expressly restored the possession of said property to LGU Bayambang, has been identified as a suitable location to serve as a temporary public parking space, helping to prevent improper parking, reduce road obstructions, and alleviate traffic congestion within the municipality;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, as the Local Chief Executive, hereby order the designation of the old Bayambang Central School lot as a temporary parking space for vehicles of LGU employees and the general public of Bayambang, Pangasinan.

SECTION 1. SCOPE. The old Bayambang Central School lot, located adjacent to Rizal Street and facing the national highway in Zone II, is hereby designated as the temporary parking space for the general public.

"Baley ko, Pawilen ko, Aroen ko, tan Tulungan ko"





SECTION 2. RULES AND REGULATIONS FOR PARKING AREA USE. The Bayambang Public Safety Office (BPSO) and the Municipal Disaster Risk Reduction Management Office (MDRRMO) shall enforce the following rules and regulations for the use of the parking area:

- 1. Vehicles must be parked in a manner that does not obstruct the path of entering and exiting vehicles in the parking area.
- 2. Parking shall be FREE of charge. Overnight parking of private vehicles is prohibited. Vehicles are allowed to park from 7:30 AM to 11:00 PM only, except for special/extraordinary/emergency circumstances which allows extension of parking time and authorized by BPSO and MDRRMO.
- 3. Washing, greasing, repairing, or any similar activities in parked vehicles, except for emergency repairs, are strictly prohibited in the designated parking area.
- 4. Cleanliness and orderliness must be maintained within the parking area and its immediate surroundings at all times.
- No signs, barriers, or other objects indicating "No Parking" or "Reserved Parking" shall be placed in the designated parking area without authorization from the Local Chief Executive.
- 6. All relevant laws, ordinances, and department orders pertaining to traffic management and road clearing must be strictly followed.

SECTION 3. SUPERVISION. The Bayambang Public Safety Office and the Municipal Disaster Risk Reduction Management Office shall collaborate to ensure the effective implementation of this Executive Order. They shall also coordinate with the Bayambang PNP for any necessary assistance.

SECTION 4. REPEALING CLAUSE. All other orders, rules, regulations, and issuances or parts thereof which are inconsistent with this Order are hereby repealed, amended, or modified accordingly.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately and shall remain in effect until amended or revoked.

Copies of this Order shall be provided to all Offices and Departments for their information and guidance.
