## **EXECUTIVE ORDER NO. 02**

## "AN ORDER CREATING THE SAFE SPACES MONITORING TEAM IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN"

WHEREAS, it is the policy of the State to value the dignity of every human person and guarantee full respect for human rights. It is likewise the policy of the State to recognize the role of women in nation-building and ensure the fundamental equality before the law of women and men. The State also recognizes that both men and women must have equality, security and safety not only in private, but also on the streets, public spaces, online, workplaces and educational and training institutions;

WHEREAS, Republic Act No. 11313 or the Safe Spaces Act, mandates the local government units to enforce the provisions of the law under Article I (Gender-Based Streets and Public Spaces Sexual Harassment);

WHEREAS, DILG Memorandum Circular No. 2023-181 dated November 17, 2023, was issued to further provide the local government units (LGUs) with guidelines on the operationalization of their LCAT-VAWC and address policy gaps;

WHEREAS, the Local Government Unit of Bayambang commit to create and keep an environment and place in all its jurisdiction where every person is respected, secured, could show and communicate their true self where there is genuine care, support system, sensitivity, equality, no judgment and no discrimination of one's gender, age, race, social standing, and experience;

**WHEREAS,** in order to make and keep every space a safe space for all in the jurisdiction of Bayambang, there is the need to create a Safe Spaces Monitoring Team to ensure that all laws, policies, and guidelines on the Safe Space Act is implemented;

**NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO,** Municipal Mayor of Municipality of Bayambang, Pangasinan, by virtue of the power vested in me by the law, do hereby order the Creation of Safe Spaces Monitoring Team of the Local Government Unit of Bayambang, Pangasinan.

**SECTION 1. CREATION AND COMPOSITION.** The Safe Space Monitoring Team is here by created, and shall be composed of the following:

**SECTION 2. DUTIES and FUNCTIONS.** The Safe Space Monitoring Team of LGU Bayambang shall be:

- 1. Primarily responsible for enforcing the provisions of RA 11313 in the entire municipality.
- 2. Ensure for the passage of an Ordinance which shall localize the applicability of RA 11313 within days upon the creation of the Team.

- 3. Disseminate or post in conspicuous places a copy of RA 11313 and the Ordinance.
- 4. Provide measures to prevent gender based sexual harassment in all institutions such as information education campaign and anti-sexual harassment seminars and all other forms harassment.

SECTION 3. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

**SECTION 4. REPEALING CLAUSE.** All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified  $\sim$  accordingly.

**SECTION 5. EFFECTIVITY.** This Executive Order shall take effect immediately and will continue until amended or revoked.

Let copies of this Order be furnished to all Offices and Departments for their information and guidance.
