AN ORDER APPOINTING MEMBERS OF THE BAYAMBANG MATALUNGGARING AWARDS SELECTION COMMITTEE OF THE LOCAL GOVERNMENT UNIT OF BAYAMBANG, PANGASINAN AND ENUMERATING THEIR POWERS AND FUNCTIONS

WHEREAS, it is a declared policy of the Local Government of Bayambang through its Municipal Ordinance No. 01, series 2021, "An Ordinance Institutionalizing the Bayambang Matalunggaring Awards: The Highest Award Conferred to Outstanding Bayambangueños in the Municipality" to recognize and award Bayambangueños in their work or profession, for their extraordinary and exemplary deeds, services and contributions to the progress and development of our municipality and our country;

WHEREAS, the Matalunggaring Awards also aims to encourage and inspire fellow Bayambangueños, specially the youth, to strive and excel in their fields of endeavor and distinguish themselves worthy of such award and emulation for their superior accomplishments, heroic deeds, exemplary and extraordinary acts or services for the progress and development of our municipality and our country;

WHEREAS, to ensure the principle of equal opportunity and strict adherence to the established guideline and mechanism for identifying, selecting, and awarding the Matalunggaring Awards, which is the highest recognition and honor to be conferred by the Municipal Government of Bayambang to deserving Bayambangueños, there shall be, under Section 4 of Municipal Ordinance No. 01, series 2021, "An Ordinance Institutionalizing the Bayambang Matalunggaring Awards: The Highest Award Conferred to Outstanding Bayambangueños in the Municipality", a selection committee consisting of a chairman and four (4) members to be appointed by the Municipal Mayor;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, by virtue of the powers vested in me by law as the Local Chief Executive, **do hereby appoint the members of the BAYAMBANG MATALUNGGARING AWARDS SELECTION COMMITTEE** of the Local Government Unit of Bayambang, Pangasinan.

SECTION 2. POWERS AND FUNCTIONS OF THE COMMITTEE. The powers and functions of the Bayambang Matalunggarang Awards Selection Committee are as follows:

1. Finalize the criteria for judging for the Bayambang Matalunggarang Awards;
2. Shall review and validate all submitted nomination forms to ensure that all technical requirements are complied with;
3. Shall convene and deliberate on the achievements and profile of the nominees; and
4. Shall select the winners and their decision will be final and unappealable.

SECTION 3. SECRETARIAT AND SCREENING COMMITTEE. Under Section 4 of Municipal Ordinance No. 01, series 2021, “An Ordinance Institutionalizing the Bayambang Matalunggaring Awards: The Highest Award Conferred to Outstanding Bayambanguenos in the Municipality” the Office of the Sangguniang Bayan Secretary shall be the Screening and Secretariat Committee.

SECTION 4. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconditional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 5. REPEALING CLAUSE. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Order, are hereby repealed, amended or modified accordingly.

SECTION 6. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
