AN ORDER EXTENDING THE DEADLINE FOR RENEWAL, APPLICATION, AND PAYMENT OF MAYOR'S PERMIT UNTIL FEBRUARY 29, 2024, IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, Chapter III, Article I, Section 444, otherwise known as the Local Government Code of 1991, grants the municipal mayor the authority to exercise powers and perform duties and functions as provided by this Code and other laws;

WHEREAS, the Local Government Unit of Bayambang, Pangasinan acknowledges the importance of supporting local businesses and promoting economic growth within its jurisdiction;

WHEREAS, the Mayor's Permit is a crucial instrument and compliance document that allows businesses to operate legally within the jurisdiction of Bayambang, Pangasinan;

WHEREAS, the Local Government Unit of Bayambang has issued Executive Order No. 09 series 2024 "An Order Extending the Deadline for Renewal, Application, and Payment of Mayor's Permit until February 15, 2024", to give consideration to business owners/applicants to process and pay for the issuance of their business permits.

WHEREAS, recognizing the impact of the global pandemic that has resulted in an economic downturn in the country, and acknowledging the challenges faced by businesses in recovering from losses, the Local Government Unit of Bayambang has decided to extend anew the deadline for the renewal, application, and payment of Mayor's Permits. This second extension of deadline aims to provide sufficient time and consideration to business owners/applicants to complete and process their documents, and pay for the issuance of their Mayor's Permit;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Pangasinan, in accordance with the authority vested in me by law, hereby extend anew the deadline for renewal, application, and payment of Mayor's Permit until FEBRUARY 29, 2024 as part of our consideration and support to our business sector still in trying times due to the effects of the pandemic and challenges in recovering from losses.

SECTION 1: EXTENSION OF RENEWAL PERIOD

The renewal period for the Mayor's Permit for all eligible businesses is hereby extended until February 29, 2024 (Thursday).

SECTION 2: NO PENALTIES

During the extension period, **NO PENALTIES** shall be imposed on all Mayor's Permit application payments. This exemption from penalties applies only to businesses with no delinquencies.

SECTION 3: APPLICATION PROCESS

Businesses seeking to renew their Mayor's Permit during the extension period shall follow the standard renewal application process outlined by the Business Permit and Licensing Office (BPLO) of the Local Government Unit of Bayambang, Pangasinan.

SECTION 4: EFFECTIVITY DATE

This Executive Order shall take effect immediately upon issuance.
