EXECUTIVE ORDER NO. 22

“REORGANIZING/RECONSTITUTING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN”

WHEREAS, the 1987 Philippines Constitution mandates that the government shall promote the quality of life of the people;

WHEREAS, Section 16 of the Local Government Code provides that the local government unites shall pursue undertakings to improve public morals and maintain peace and order, among other equally significant concerns;

WHEREAS, the increasing use of illegal drugs has significantly contributed to the incidence of the heinous crimes;

WHEREAS, DILG Memorandum Circular No. 98-227 dated December 2, 1998, as amended, enjoins local government units to create their local Anti-Drug Abuse Councils;

NOW, THEREFORE I, MARY CLARE JUDITH PHYLLIS JOSE QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan by virtue of powers vested in me by law, do hereby reorganize/reconstitute the Municipal Anti-Drug Abuse Coordinating Council of the Municipality of Bayambang, Pangasinan as follows:


SECTION II. ROLES AND RESPONSIBILITIES

- A. Serve as a focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on the drug prevention;
- B. Provide for effective mechanisms for the coordination of existing services and programs and those which might be developed in the immediate future;
- C. Provide for a mechanism to obtain funds, volunteers, facilities and technical expertise; and
- D. Perform other related responsibilities as may be assigned by competent authorities.

SECTION III. MEETINGS. The council shall meet every 3rd week of the first month of every quarter.

SECTION IV. EFFECTIVITY. This Executive Order shall take effect immediately.
