## AN ORDER ADOPTING THE MANUAL OF PROCEDURES FOR THE PHILIPPINE INTEGRATED DISEASE SURVEILLANCE AND RESPONSE (PIDSR) IN THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, Section 15 of the 1987 Constitution declares that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the State also recognizes that disease surveillance and response systems are among the first lines of defense against epidemics and health concerns that pose risk to public health and security;

WHEREAS, in April 2014, the Department of Health has issued the Manual of Procedures for the Philippine Integrated Disease Surveillance and Response (PIDSR) which is intended to be used as a general reference for surveillance activities across all levels, a resource to empower people through training, supervision and evaluation of surveillance activities and as guide for improving early detection and preparedness activities for improved and timely response to epidemic and other health concerns:

WHEREAS, the Provincial Government of Pangasinan, through Executive Order No. 0054 series 2023, adopted the Manual of Procedures for the Philippine Integrated Disease Surveillance and Response (PIDSR) for implementation as guide to reduce mortality and/or disability caused by communicable diseases;

WHEREAS, the Procedures for the Philippine Integrated Disease Surveillance and Response (PIDSR) system aims to improve the detection, reporting, and response to priority infectious diseases and other public health threats;

WHEREAS, there is a need to adopt the Manual of Procedures for the Philippine Integrated Disease Surveillance and Response (PIDSR) in order enhance the existing disease surveillance and response system in the Municipality of Bayambang to better protect public health and ensure timely and effective responses to disease outbreaks and health emergencies in the municipality;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, by the virtue of the powers vested in me by law, do hereby order the following;

SECTION 1. ADOPTION OF THE MANUAL OF PROCEDURE FOR THE PHILIPPINE INTEGRATED DISEASE SURVEILLANCE AND RESPONSE

(PIDSR). The Manual of Procedures for the Philippine Integrated Disease Surveillance and Response (PIDSR) is hereby adopted to serve as a guide in the management and response for all health threats within the municipality.

**SECTION 2. DUTY OF THE MUNICIPAL HEALTH OFFICE.** The Municipal Health Office is hereby designated to be the office primarily responsible for the implementation, observation and in executing recommended action relative to the Manual.

**SECTION 3. REPEALING CLAUSE.** All Executive Orders, and issuances inconsistent herewith are hereby repealed, amended or modified accordingly.

**SECTION 4. SEPARABILITY CLAUSE.** Any provision of this order that is declared unconstitutional or violative of existing laws, rules and regulations, shall not invalidate the other provisions not affected thereby.

**SECTION 5. EFFECTIVITY.** This Executive Order shall take effect immediately upon approval.

This Executive Order shall be disseminated and implemented accordingly.
