### EXECUTIVE ORDER NO. 23

#### REORGANIZATION/RECONSTITUTION OF THE LOCAL COUNCIL FOR PROTECTION OF CHILDREN (LCPC)

**WHEREAS**, pursuant to Department of the Local Government (DILG) Memorandum Circular No. 2021-039 dated April 07, 2021, Local; Government Units are encouraged to establish their respective Local Council for the Protection of Children (LCPC) per provision of Articles 359 and 360 of the Civil Code and Presidential Decree (PD) 603, will shall be responsible in planning and spearheading programs for children in the locality with the end view of making the locality child-friendly;

**WHEREAS**, Republic Act No. 9344, as amended by Republic Act No. 10630, the Juvenile Justice and Welfare Act mandate the local government units (LGUS) to establish their respective LCPC, and to allocate at least 1% of their internal revenue allotment (IRA) for its strengthening. Furthermore, the law mandates the LCPCs' participation in the development and implementation of a local comprehensive plan on delinquency prevention;

**NOW THEREFORE, I, HON. MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO**, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan, and by virtue of the powers vested in me by law, do hereby order and direct the following:

## **SECTION II. FUNCTIONS**

The Council has the following functions:

1. Formulate, develop, coordinate, monitor and review all local policies (to include BCPC prepared and issued policies), ordinances, plans, programs, and activities which shall promote the best interest and rights of children and ensure mainstreaming in the local development agenda;

2. Prepare an Annual Work and Financial Plan consistent with its function as provided herein and in the local EO creating it;
3. Establish, maintain and update a disaggregated database or local information system on all children within the city/municipality and shall include the information gathered by the BCPC;
4. Conduct advocacy activities on the promotion and protection of the rights and welfare of children including the development of information, education and advocacy materials;
5. Conduct capability-building activities for all stakeholders on children including in the barangay level;
6. Provide assistance to children in need of special protection;
7. Document good practice/s on children;
8. Coordinate and consult with other LCPCS, LGUs and other regional and national authorities with respect to policies and PPAs on children;
9. Organize the necessary documents needed by the concerned IMTF; and
10. Conduct the Child-Friendly Local Governance Audit (CFLGA), through the LCPC Inter-Agency Monitoring Task Force (IMTF), annually;

**SECTION III.** The Sangguniang Bayan of Bayambang, Pangasinan shall set aside funds which may be necessary to carry out the specific roles and responsibilities in pursuance of this Order.

**SECTION IV.** Other members may be added to the council from time to time as need arises.

**SECTION V.** This Executive Order shall take effect immediately and will continue until amended or revoked.
