# AN ORDER REORGANIZING/ RECONSTITUTING THE LOCAL HIV-AIDS BOARD OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, Sec. 16 of the Local Government Code of 1991 mandates all LGUs to ensure the welfare of the constituents, specifically identified as the promotion of health and safety;

**WHEREAS,** Republic Act 8504 (Aids Prevention and Control Act of 1988) to promulgate policies and prescribe measures for the prevention and control of (HIV/AIDS) in the country;

WHEREAS, cases of the dreaded HIV-AIDS in the country has tremendously increased thereby necessitating the LGUs to take a lead in the implementation of programs/projects/activities to combat its spread in the locality;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of the Municipality of Bayambang, Pangasinan by virtue of the power vested in me by law, do hereby reorganize the Local HIV-AIDS Board of the Municipality of Bayambang, as follow:

**SECTION 1. COMPOSITION.** The Municipal HIV-AIDS Board shall be composed of the following member:

## SECTION 2. FUNCTIONS. The HIV-AIDS Board shall perform the following functions:

- 1. To serve as an advisory body for the comprehensive and integrated HIV-AIDS prevention and control program in the LGU;
- Coordinate with the Local Sanggunian specifically on the Committee on Health and recommend the passage of HIV-AIDS related resolution, ordinance and other policies;
- 3. Institution of a municipal-wide HIV/AIDS information and education program;
- 4. Establishment of a comprehensive HIV/AIDS monitoring system;
- 5. Coordinate activities and strengthen working relationship between government and non-government agencies involved in the campaign against HIV/AIDS.

**SECTION 3. MEETING.** The HIV-AIDS Board shall meet every month on a day and time agreed upon by the members. Special meetings will be conducted if deemed necessary.

**SECTION 4. SECRETARIAT.** The Municipal Health Officer is hereby designated as the Secretariat of the Municipal HIV-AIDS Board who shall have the following functions:

- 1. Draft the Municipal HIV-AIDS Board Plan in close coordination with the Board Chairman and Members;
- 2. Monitor the implementation of the plan and provide feedback to the Board;
- 3. Send out notice of meetings and follow-up attendance thereto; and
- 4. Prepare the minutes of the meetings of the Board and furnish same to all members.

**SECTION 5. EFFECTIVITY.** This Executive Order shall take effect immediately and will continue until amended or revoked.
