AUTHORIZING THE TRANSFER OF APPROPRIATION UNDER THE OFFICE OF THE RURAL HEALTH UNIT II

WHEREAS, the amount left under account **RURAL HEALTH UNIT II-OTHER MAINTENANCE AND OPERATING EXPENSES AND DRUGS AND MEDICINES** are not sufficient to meet the obligations;

WHEREAS, the total amount of ONE HUNDRED THIRTY THREE THOUSAND FIVE HUNDRED PESOS ONLY (P 133,500.00) is available to augment the balance under account **RURAL HEALTH UNIT II-FUEL, OIL AND LUBRICANTS AND MEDICAL, DENTAL AND LABORATORY SUPPLIES** to be used for the purchase of drugs and medicines and various activities of RHU I;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, by virtue of the powers vested in me by law as the Local Chief Executive, do hereby authorize Municipal Budget Officer Peter B. Caragan to transfer the ONE HUNDRED THIRTY THREE THOUSAND FIVE HUNDRED PESOS ONLY (P 133,500.00)

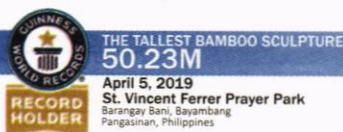
