### EXECUTIVE ORDER NO. 51

*Series of 2024*

#### **“REORGANIZING/RECONSTITUTING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN”**

**WHEREAS**, the 1987 Philippines Constitution mandates that the government shall promote the quality of life of the people;

**WHEREAS**, Section 16 of the Local Government Code provides that the local government units shall pursue undertakings to improve public morals and maintain peace and order, among other equally significant concerns;

**WHEREAS**, the increasing use of illegal drugs has significantly contributed to the incidence of heinous crimes;

**WHEREAS**, DILG Memorandum Circular No. 98-227 dated December 2, 1998, as amended, enjoins local government units to create their local Anti-Drug Abuse Councils;

**NOW, THEREFORE I, MARY CLARE JUDITH PHYLLIS JOSE QUIAMBAO**, Municipal Mayor of the Municipality of Bayambang, Province of Pangasinan by virtue of powers vested in me by law, do hereby reorganize/reconstitute the Municipal Anti-Drug Abuse Coordinating Council of the Municipality of Bayambang, Pangasinan as follows:

## **SECTION II. ROLES AND RESPONSIBILITIES**

- A. Serve as a focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on the drug prevention;
- B. Provide for effective mechanisms for the coordination of existing services and programs and those which might be developed in the immediate future;
- C. Provide for a mechanism to obtain funds, volunteers, facilities and technical expertise; and
- D. Perform other related responsibilities as may be assigned by competent authorities.

**SECTION III. MUNICIPAL ANTI-DRUGS ABUSE COUNCIL SECRETARIAT.** The PNP shall act as the secretariat of the MADAC and shall be assisted in its functions and duties by the focal person of the council. The Secretariat shall also undertake liaison and coordination of activities with appropriate agencies of the government.

**SECTION IV. MEETINGS.** The council shall meet every 3<sup>rd</sup> week of the first month of every quarter.

**SECTION V. EFFECTIVITY.** This Executive Order shall take effect immediately.
