AN ORDER RECONSTITUTING/REORGANIZING THE COMPOSITION OF THE MUNICIPAL PRICE COORDINATING COUNCIL OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN

WHEREAS, Republic Act. No. 7581 as further amplified by DILG Memorandum circular No. 20017-75 dated June 21, 2007, provides for the creation and activation of the Local Price Coordinating Council to monitor, convene and formulate policies and strategies to keep prices of basis consumers goods at reasonable levels;

WHEREAS, the Municipal Price Coordinating Council plays a crucial role in ensuring the stability of prices and the availability of essential commodities within the municipality;

WHEREAS, there is a need to recompose the Municipal Price Coordinating Council to enhance its effectiveness and ensure broader representation from various sectors and to strengthen the coordination and implementation of price control measures and address the needs of the community more effectively;

NOW THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Municipality of Bayambang, Pangasinan, by virtue of the powers vested in me by law, do hereby the reorganization/reconstitution of the Municipal Price Coordinating Council of the Municipality of Bayambang as follows:

SECTION 1. COMPOSITION. The Municipal Price Coordinating Council of the Municipality of Bayambang shall be composed with the following members:

SECTION 2: DUTIES AND FUNCTIONS:

- A.** Coordinating and rationalize the programs to stabilize prices and supply of member's agencies in the Municipal;
- B.** Recommend to the NPCC or the Implementing Agencies suggested retail prices (SRP) and/ or the price ceiling for certain basic necessities and prime commodities in their respective areas;
- C.** To conduct in depth-analysis on cause for the price increase and supply shortages; and
- D.** To recommend action steps to correct unwanted price increase and supply shortages.

SECTION 3. EFFECTIVITY.

This Executive Order shall take effect immediately and will continue until amended or revoked.
