ORGANIZATION OF THE MUNICIPAL VALIDATION AND ASSESSMENT TASK TEAM (MVATT) OF HAPAG AND KALINISAN SA BAGONG PILIPINAS PROGRAM OF THE MUNICIPALITY OF BAYAMBANG

WHEREAS, in line with the thrust of the Marcos Administration to address food security in the country, the DILG introduced the Halina't Magtanim ng Prutas at Gulay (HAPAG) sa Barangay Project through the issuance of DILG MC No. 2023-001 dated January 3, 2023 to serve as a strategy to diversify food sources and contribute to ensuring food security in the community;

WHEREAS, relative to the DILG MC No. 2023-133 dated September 6, 2023 regarding Barangay at Kalinisan Day (BarKaDa) as the nationwide community-based clean-up drive program anchored on the culture of bayanihan which provides guidance in the conduct of regular clean-up drives at the barangay level;

WHEREAS, pursuant to DILG Memorandum Circular 2024-01 dated January 3, 2024 that introduced the KALINISAN (Kalinga at Inisyatiba para sa Malinis na Bayan) sa Bagong Pilipinas Program, a convergence initiative of the DILG to consolidate and intensify all efforts to maintain and provide healthy and safe environment for all by capacitating local government units and enabling community participation anchored on a new brand of "Bayanihan;

WHEREAS, DILG Urgent Memorandum dated June 14, 2024 and the Revised Guidelines in the conduct of Validation and Assessment under Kalinisan sa Bagong Pilipinas Program require the organization of the Validation and Assessment Task Team for HAPAG and BARKADA (Cleanest Barangay) for the Municipality of Bayambang, Pangasinan. Hence:

SECTION 2. POWERS AND FUNCTIONS OF THE MVATT- The members of the Municipal Validation and Assessment task team shall perform the following tasks:

- a. Provide technical and administrative assistance to the barangays;
- b. Identify the Top barangays that will be subjected for validation and assessment;
- c. Conduct the table assessment and ocular inspection;
- d. Identify the schedule for ocular inspection;
- e. Prepare the consolidated report and encode the results in the shared google drive;
- f. Ensure completeness and accuracy of the encoded results of the assessment;
- g. Submission to provincial level the municipal consolidated assessment results;
- h. Provide copy of the approved results of the assessment to the LGU and barangays within the area of responsibility; and
- i. Publish the top barangays in the official social media platforms and communicate the said top barangays to the municipal government for their information

SECTION 3. EFFECTIVITY- This order shall take effect immediately.
