EXECUTIVE ORDER NO. 66

AN ORDER AMENDING SECTION 3 OF EXECUTIVE ORDER NO. 62 REGARDING THE FOUR-DAY (COMPRESSED) WORKWEEK IN THE LOCAL GOVERNMENT UNIT OF BAYAMBANG, PANGASINAN

WHEREAS, Executive Order No. 62, Series of 2024 entitled “Extending the Effectivity of the Four-day (Compressed) Workweek in the Local Government of Bayambang” was issued on June 24, 2024;

WHEREAS, the implementation of the compressed four-day workweek has resulted in significant energy consumption savings, further demonstrating its positive impact;

WHEREAS, Section 3 enumerates all the frontline services that shall continue to operate five days a week and regular working hours;

WHEREAS, the Local Civil Registrar and Municipal Assessor's Office are considered frontline services due to the essential nature of the services they provide to the public such as vital record-keeping of birth certificates, marriage licenses, death certificates, issuance of new or certified copies of tax declarations of real property, and other important documents;

WHEREAS, the continued implementation of the compressed four-day workweek will further enhance the efficiency and productivity of our workforce;

NOW, THEREFORE, I, MARY CLARE JUDITH PHYLLIS JOSE-QUIAMBAO, Municipal Mayor of Bayambang, do hereby order:

SECTION 1. PURPOSE. This amendment aims to ensure continuous and uninterrupted services to the public by requiring the Local Civil Registrar and the Municipal Assessor's Office to operate on Fridays, recognizing their role as frontline services.

SECTION 2. AMENDMENT TO SECTION 3 OF EXECUTIVE ORDER NO. 62, SERIES OF 2024. The Local Civil Registrar and Municipal Assessor's Office shall be added to the list of frontline services that are required to report to work on Fridays from 8:00 AM to 5:00 PM.

SECTION 3. IMPLEMENTATION. The Local Civil Registrar and Municipal Assessor's Office shall begin operating on Fridays starting this Friday, July 12, 2024.
